### About this Report and the World Database on Protected Areas (WDPA)

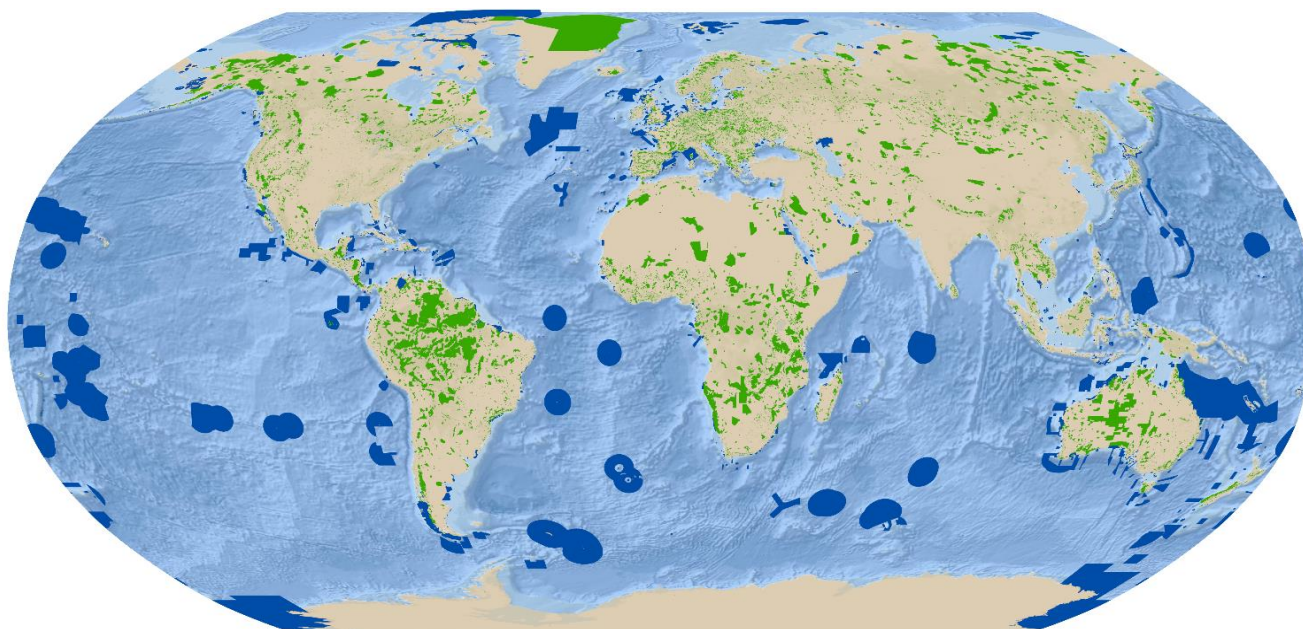

The WDPA is the most comprehensive global dataset on terrestrial and marine protected areas, incorporating the official UN List of Protected Areas. The WDPA dataset is not necessarily a complete representation of all the protected areas which have been designated in country. The quality of the WDPA depends on the accessibility of accurate, comprehensive, up-to-date protected areas information from data holders.

This report describes the current status of data in the WDPA for all sites included in the April 2023 monthly release.

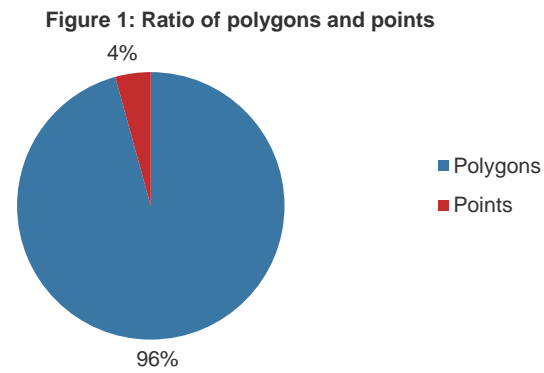

## Protected areas data in the WDPa

There are 285,346 protected area records stored in the WDPa. 251,051 are national-level protected areas with 34,042 designated under international and regional agreements or conventions. 96% of the data have boundaries in polygon format, with the remaining 4% depicted in point format (i.e. a single latitude and longitude point for the protected area). 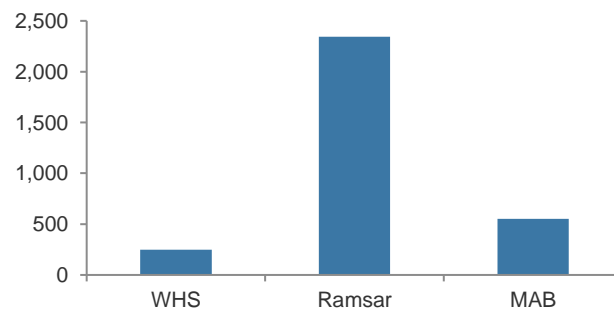
Of the 285,346 protected areas, 18,415 (6%) include a marine or coastal component. These protected areas may be either partially or completely within the marine environment.

### Data for protected areas designated under international conventions and agreements

There are 3,146 protected areas in the WDPa designated under international conventions or agreements.

250 are World Heritage sites (WHS), 2,344 are Ramsar Wetlands of International Importance, 552 are UNESCO Man and the Biosphere Reserves (MAB). See Figure 2.

### Data for protected areas designated under regional conventions and agreements

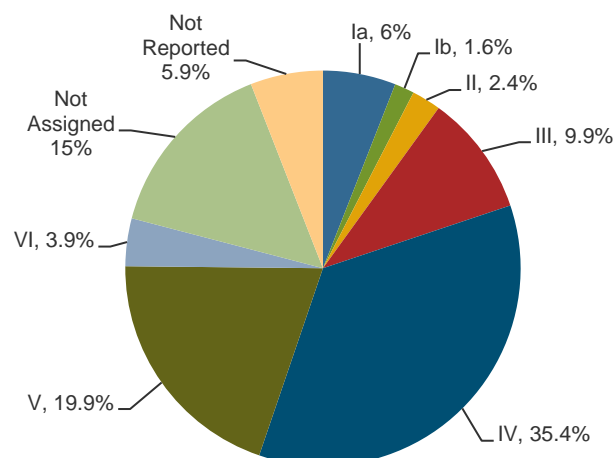
There are 30,896 protected areas in the WDPa designated under regional conventions or agreements. 28,947 are Natura2000 sites, 749 sites are designated under regional seas conventions and 1,200 are Areas of Special Conservation Interest (Emerald Network).

### Data for national-level protected areas

There are 251,051 national-level protected area records in the WDPa. IUCN Management Categories have been reported for 198,499 of these records. The remaining 52,552 are recorded as Not Reported and Not Assigned.

Figure 3 shows the allocation of IUCN Management Categories across national-level protected area records in the WDPa (numbers of sites in each category are shown in Table 2 at the end of this report).

### Data for areas protected by local communities, indigenous people and private entities, through non-legal means

There are 253 records in the WDPa that are established through non-legal means.

## Completeness of WDPA Data Attributes

The WDPA requires that a minimum set of information is provided with each protected area record. These data attributes are defined by the WDPA Data Standard.

Table 1 shows the extent to which key attributes have been reported by data providers for all protected area records in the WDPA.

## Data sources in the WDPA

Data for protected area records in the WDPA have been obtained or validated from over 400 sources.

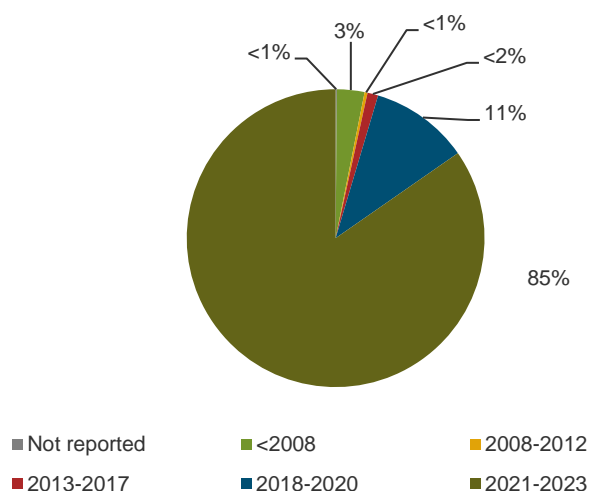
Figure 4 shows the breakdown of when protected area records in the WDPA were last updated or validated.

Data for protected areas designated under international agreements and conventions have been sourced from the relevant convention secretariat. This includes: UNESCO World Heritage Centre, Ramsar Convention Secretariat and UNESCO Man and The Biosphere Programme.

Data for national-level protected areas in the WDPA have been sourced from national authorities wherever possible. Information may also be supplemented by data from other agencies or organisations working in each country. As part of the update process for national data, national authorities are given the opportunity to review, validate and, where necessary, edit all existing WDPA records for their country. All updates to the WDPA by national authorities take priority over other sources and are considered to be the authoritative version.

There are 746 records in the WDPA with no reported source.

## WDPA Quality Indicators

---

### *The percentage of records with boundaries in polygon format*

The WDPA stores all records with spatial (location) data. These data can be polygons which represent the boundaries of the protected area, or a single latitude/longitude point which shows the general location of the protected area. This indicator shows the percentage of records with boundaries - the preferred spatial data.



### *The percentage of data attributes which have been reported by the data provider*

Each record in the WDPA has 25 fields for which data attributes are requested. This indicator shows the weighted percentage of data fields which have been reported, based on the minimum and complete attributes.



### *The percentage of records updated or validated by the data provider in the last 5 years*

UNEP-WCMC sets a target to update each record in the WDPA at least every five years. This indicator shows the percentage of records updated in the last 5 years (April 2018 to April 2023).



### *The percentage of records where the area of the polygon is within 5% of the area reported*

The area (km<sup>2</sup>) reported for a protected area may sometimes differ from the area of the boundary polygon provided, possibly indicating a discrepancy within the information submitted. This indicator shows the percentage of records where the area of the polygon is within a threshold of 5% of the area reported. The threshold allows for differences due to projections and software used for calculating the GIS area.
