PARTNERSHIP UPDATES

- **Proteus 2026-2030 Strategy:** UNEP-WCMC is finalising the strategy for the next strategic phase of the Proteus Partnership. We are grateful for extensive input and feedback received from Proteus partners and selected other businesses. The final strategy summary document will be shared in the coming weeks.
- [UNEP-WCMC Impact Report 2023-2024](#): Our latest impact report showcases how UNEP-WCMC has brought about nature action by providing world-leading data and tools, and offering vital guidance and support through our work with governments, businesses, the scientific community, Indigenous Peoples, local communities, and civil society.
- **Direct support to Proteus partners:** UNEP-WCMC has delivered six training sessions, over 85 hours of technical assistance, and successfully resolved 23 data queries for Proteus partners in Q2 2025. DATA UPDATES

- **World Database on Protected Areas (WDPA):** 34 countries were updated in the second quarter of 2025 including 11 Proteus Priority Countries (Bulgaria, Colombia, Egypt, Finland, Germany, Greece, Italy, Peru, Netherlands, Spain, and Sweden). These updates included 30,900 records with updated and verified data, 240 records added to the WDPA, and 179 records removed from the WDPA.
- **World Database on Other Effective Area-Based Conservation Measures (WD-OECM):** The Northwest Atlantic Fisheries Organization (NAFO) contributed 18 new Area Beyond National Jurisdiction (ABNJ) sites in May; the North-East Atlantic Fisheries Commission (NEAFC) partially updated all their existing 20 ABNJ sites in June, and one OECM was also added for Peru in June.
- **WDPA and WD-OECM merge:** From 1st August 2025 the WDPA and WD-OECM will be merged into one database. This is to streamline data management processes and simplify how external users access the two datasets, allowing users to identify all protected and conserved areas with one dataset. - **IBAT:** The IUCN Red List spatial data was updated in April 2025 to include the first 1,000 of the world's 155,000 known fungal species threatened by deforestation, agricultural expansion and urban development. The World Database on Key Biodiversity Areas was updated in May 2025 to include 113 new Important Bird and Biodiversity Areas in Italy.
